COMPANY OVERVIEW

An integrated agri-business company that focuses on commercial egg production, commercial broiler processing, chicken and fish feed production, food processing and packaging, and the sales and distribution of Agri-products. The company commenced operations in the year 2012 but was incorporated in 2013.

In 2019, Mayor Farms was recognized as a "Company to inspire Africa" by the London Stock Exchange group. Over the years the company has invested greatly in the expansion of its production capacity, leading to a steady growth in turnover.

- 2022 15,000 BROILER BIRDS WEEKLY, 1000 EGG CRATES (30,000 EGGS) WEEKLY Current capacity on 40 acres of land

THE TRANSACTION


- According to the Central Bank of Nigeria, the poultry sub-sector contributes roughly 25% of agricultural GDP to the Nigerian economy.
- Despite this, the processed chicken market remains largely untapped locally, forcing the nation to rely on importation to meet demand.
- Mayor Farms has been given the opportunity to become a major supplier for a large fastfood franchise based in Nigeria. However, they would have to increase their weekly output from 2,000 birds/week to 10,000 birds/week to meet customer demand.

To maximize capacity and meet demand, Mayor Farms requires N400 million to:

Increase rearing capacity: 250k birds to 500k birds annually Purchase new broiler processing plant and birds from out growers

Expansion of cold chain facilities and feed mill capacity

purchase 200kwat solar plant and 300l water storage
